*Article I - Name*

The name of this Corporation is:

*Article II - Principal Office and Mailing Address*

*Article III - Duration*

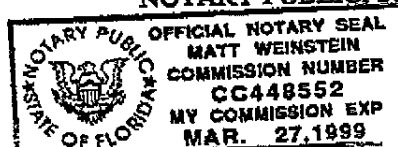

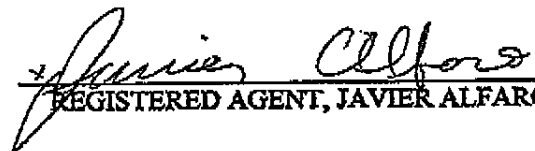
