# ARTICLES OF INCORPORATION OF

### AMAZING DAYS SCHOOL & STUDIO, INC.

#### ARTICLE I

The name of this corporation is Amazing Days School & Studio, Inc.

#### ARTICLE II

The principal purposes for which the corporation is organized are:

- 1. To own and operate a pre-kindergarten school and before and after child care.


