TO
ARTICLES OF INCORPORATION

THIS AMENDMENT TO THE ARTICLES OF INCORPORATION
"Amendment") was adopted on the 28th day of February, 2011 by the Shareholder of
PINNACLE MEDICAL GROUP, P.A., a Florida professional service corporation (the
"Corporation") pursuant to Section 607.1006, Florida Statutes.

WITNESSETH:

WHEREAS, the Corporation's original Articles of Incorporation, document
number P97000098290, were filed with the Florida Secretary of State on November 18,
1997, as amended on December 31, 1997 and December 27, 2000 (the "Articles"); and

WHEREAS, the Corporation, its Board of Directors and Shareholder believe it to
be in their best interests to change the name of the Corporation.

NOW, THEREFORE, pursuant to the provisions of Florida Statutes Section
607.1003 the Corporation hereby adopts the following Amendment to its Articles:

1. The name of the Corporation is BRADENTON MEDICAL GROUP, P.A.
2. Except as specifically amended herein, all terms, provisions and
conditions of the Articles shall remain unmodified, and otherwise in full force and effect.
3. The foregoing Amendment was approved and ratified by all of the

with Florida Statutes Chapter 607 and the Corporation's Bylaws. Therefore, the Secretary
of State is hereby requested to approve and file this Amendment in accordance with
