

ARTICLES OF INCORPORATION

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME. The name of this corporation is Processing Systems Inc.

ARTICLE II. NATURE OF BUSINESS. This corporation may engage in any activity of business permitted under the laws of the United States and the State of Florida.

ARTICLE III. CAPITAL STOCK. The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is five hundred (500) shares of no par value common stock.

ARTICLE IV. INITIAL CAPITAL. The amount of capital with which this corporation will begin business is one thousand (\$1000.00) Dollars.

ARTICLE VIII. INITIAL DIRECTORS. The names and addresses of the initial Directors are:



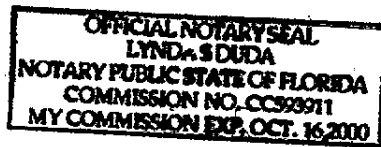


