**NAME**

This corporation shall have all of the corporate powers enumerated in the Florida general corporation act.


**ARTICLE X**

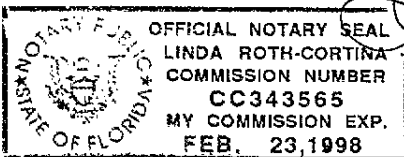



