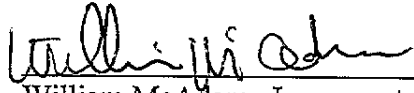

ARTICLE TEN: CONTRACTS WITH OTHER CORPORATIONS

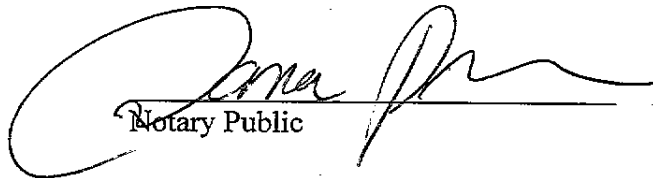
