ARTICLE I

NAME AND ADDRESS

The name of the corporation is: Sun Services, Inc.

ARTICLE II

PURPOSE

- 1. To conduct general business related to the cleaning of offices and private homes. To include but not limited to: general cleaning, handiman repairs and small renovations.
- 2. To purchase, buy, sell, and exchange related equipment and machinery; and to do all things incidental to the accomplishment of the foregoing purposes.
- 3. To engage in real estate investments; to include: buying, renting, and selling of properties. To include all other activities related to the aforementioned.
- 4. To perform stenographic, clerical, secreatrial and bookkeeping services to individuals and small companies within the state of Florida.
- 5. To provide elderly care services relating to the running of small errands and light chores with regard to daily care.
- 6. To engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE III

CAPITAL STOCK

This corporation is authorized to issue 10,000 shares of common stock.

The common stock of this corporation shall have the following characteristics:

- (a) Par value shall be \$0. 10 per share.
- (b) At all meetings of the stockholders the common stockholders shall be entitled to cast (1) vote for each share of common stock owned. That a common stockholder is interested in a matter to be voted upon shall not disqualify him form voting thereon.
- (c) Except as otherwise provided by law, the entire power for the election of directors and for all other purposes shall be vested exclusively in the holders of the common stock.
- (d) Preemptive rights shall attach to all shares of common stock.

ARTICLE IV

INITIAL BOARD OF DIRECTORS

This corporation shall have two (2) directors initially.
