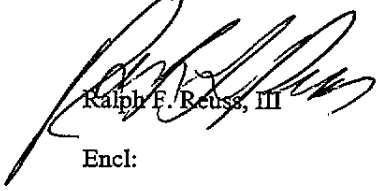

ARTICLE I - Name and Address

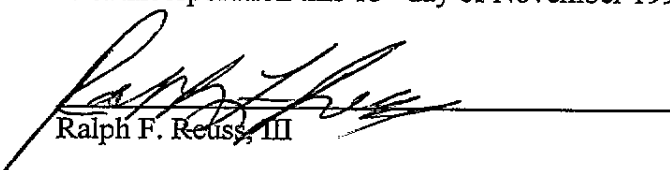
ARTICLE. VII - Indemnification

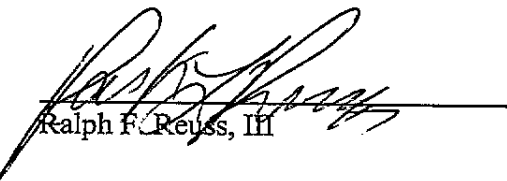
