

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF NEW TOURING, INC.



Articles V and VII of the Articles of Incorporation of New Touring, Inc. was amended by the corporation's Board of Directors on December <u>31</u>, 1997. The Corporation files these Articles of Amendment to Articles of Incorporation pursuant to F.S. 607.0602.

- 1. The name of the corporation is New Touring, Inc.
- 2. Article V of the Articles of Incorporation of New Touring, Inc. was amended as follows:

"The total aggregate number of shares which this corporation shall have the authority to issue is the total sum of 100 shares of Class A voting stock and 300 shares of Class B non-voting stock, all shares (voting and non-voting) having par value of \$1.00. The preferences, limitations, and relative rights. of Class A voting stock and Class B non-voting stock shall be the same."

3. Article VII of the Articles of Incorporation of New Touring, Inc. was amended as follows:
