THE UNDERSIGNED, acting as (an) incorporator(s) of a corporation adopt so the TATE following Articles of Incorporation for such corporation:

- 1. The name of the corporation is <u>Visioneering Consultants</u>, <u>Inc.</u>
- 2. The period of duration of the corporation is perpetual.
- 3. The purpose or purposes for which the corporation is organized are to engage in fundraising and nonprofit management consulting, association management services and provided computer networking capabilities and services to consumers and to do everything necessary, proper, advisable, or convenient for the accomplishment of said purposes, and to do all other things incidental to them or connected with them that are not forbidden by the state of Florida. In addition to the stated purpose, the corporation is authorized to conduct all lawful business activity in the state and outside.
