**ARTICLES OF INCORPORATION  
OF**

THE UNDERSIGNED, being of legal age and a natural person, does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a Corporation under the laws of the State of Florida.

**ARTICLE I**

The name of this corporation shall be:

DENNIS E. PLATT, M.D., P.A.

(the "Corporation"), and its initial address shall be:

100 East Sybelia Avenue, Suite 210  
Maitland, Florida 32751

**ARTICLE II**

**PURPOSE**

The Corporation may only engage in any activity or business permitted by the laws of the State of Florida and shall engage in the practice of medicine.

**ARTICLE III**

**AUTHORIZED CAPITAL STOCK**

The Capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows:

##### CORPORATE DURATION AND COMMENCEMENT OF EXISTENCE

**LIMITED LIABILITY OF SHAREHOLDERS**

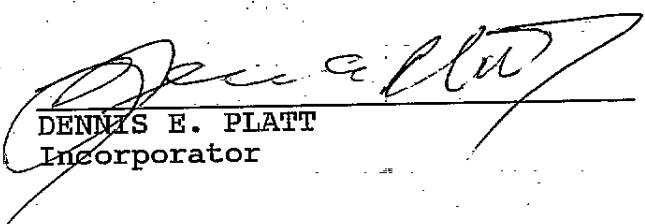
The private property of the shareholders shall not be subject to payment of the Corporation's debts to any extent.

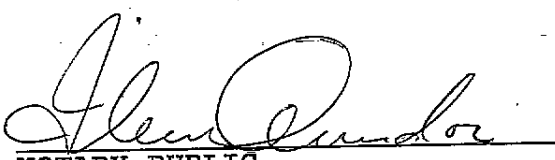

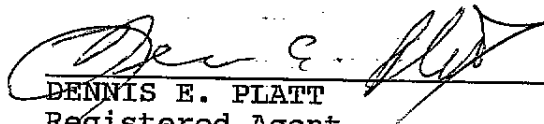
