The undersigned, acting as incorporators of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation.

**ARTICLE ONE**

**NAME**

The name of the Corporation is Worth Builders of Palm Beach, Inc.

**ARTICLE TWO**

**DURATION**

This Corporation shall have perpetual existence commencing on the date of the filing of these Articles of Incorporation with the Florida Department of State.

**ARTICLE THREE**

**PRINCIPAL OFFICE**

The address of the principal office of the Corporation is 1137 Clare Avenue, West Palm Beach, Florida 33401.

**ARTICLE FOUR**

**CAPITAL STOCK**

The number of shares of stock that the Corporation is authorized to have outstanding at any one time is Ten Thousand (10,000), all of which shall be common shares with a par value of \$1.00.

**PREEMPTIVE RIGHTS**
