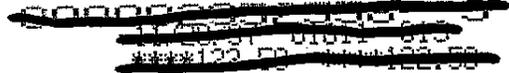

ARTICLE I - NAME

The name of this corporation is NAPLES SIGNATURE SERVICES, INC.

ARTICLE II - DURATION

The corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

The purpose of this corporation is to engage in janitorial and cleaning service and all activities relating thereto.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares which this corporation is authorized to have outstanding at any time is 1,000 shares of common stock having no par value.

ARTICLE VI - INITIAL BOARD OF DIRECTORS

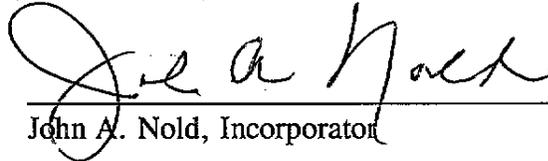
