**ARTICLE I: NAME**

The name of the corporation is: Caban Family Lawn & Outdoors Maintenance, Inc.

**ARTICLE II: NATURE OF BUSINESS**

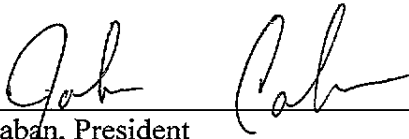

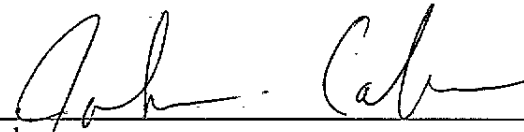
