ARTICLES OF AMENDMENT  
TO THE ARTICLES OF INCORPORATION OF  
ADVANCED DENTAL CARE OF LAKELAND, P.A.

The undersigned, Dennis A. Corona, President of Advanced Dental Care of Lakeland, P.A. does hereby certify that:

1. He is the President of Advanced Dental Care of Lakeland, P.A., a Florida corporation, which Articles of Incorporation were filed with the Secretary of State, State of Florida, on November 20, 1997.

2. The following amendment to the Articles of Incorporation was unanimously adopted by the Board of Directors and unanimously approved by the Shareholders, by written consent in lieu of a special meeting on December 19, 1997.
