ARTICLES OF INCORPORATION

OF

Simon Tsang, P.A.

I, the undersigned, hereby make, subscribe, acknowledge and file with the Secretary of State of the State of Florida these Articles of Incorporation for the purpose of forming a professional service corporation in accordance with Chapter 621 of the Florida Statutes.

ARTICLE I

Name

The name of the professional service corporation shall be:

Simon Tsang, P.A.

The principal office and mailing address of this corporation shall be 3837 Northdale Boulevard #302, Tampa, Florida 33624.

ARTICLE II

Existence of Corporation

This corporation shall have perpetual existence.

ARTICLE III

Purposes

The corporation shall engage in the practice of immigration and nationality law and procedure only and any or all related lawful business for which a professional service corporation so engaged may be incorporated under the laws of the State of Florida.

ARTICLE IV

General Powers

The corporation shall have power, as necessary for the rendering of the professional services as set forth in Article III:

- (a) To sue and be sued, complain, and defend in its corporate name.
- (b) To have a corporate seal, which may be altered at will and to use it or a facsimile of it, by impressing or affixing it or in any other manner reproducing it.
- (c) To purchase, receive, lease, or otherwise acquire, own, hold, improve, use, and otherwise deal with real or personal property or any legal or equitable interest in property.
- (d) To sell, convey, mortgage, pledge, create a security interest in, lease, exchange, and otherwise dispose of all or any part of its property.
- (e) To purchase, receive, subscribe for, or otherwise acquire; own, hold, vote, use, sell, mortgage, lend, pledge, or otherwise dispose of; and deal in and with shares or other interests in any other type of investments necessary for the rendering of professional services.
- (f) To make contracts and guarantees, incur liabilities, borrow money, and secure any of its obligations by mortgage or pledge of any of its property, and income and make contracts of guaranty and suretyship necessary for the rendering of professional services.
- (g) To lend money, and receive and hold real and personal property as security for repayment as necessary for the rendering of professional services.

- (h) To make and amend bylaws, not inconsistent with its Articles of Incorporation or with the laws of the State of Florida, for managing the business and regulating the affairs of the corporation.
- (i) To make donations for the public welfare or for charitable, scientific, or educational purposes.
- (j) To make payments or donations or do any other act not inconsistent with law that is necessary for the rendering of professional services.
- (k) To pay pensions and establish pension plans, pension trusts, profit-sharing plans, share bonus plans, share option plans, and benefit or incentive plans for any or all of its current or former directors, officers, employees, and agents and for any or all of the current or former directors, officers, employees, and agents of its subsidiaries.
- (I) To provide insurance for its benefit on the life of any of its directors, officers, or employees, or on the life of any shareholder for the purpose of acquiring at his or her death shares of its stock owned by the shareholder or by the spouse or children of the shareholder.
- (m) To be a promoter, incorporator, partner, member, associate, or manager of any professional service corporation, partnership, professional limited liability company or any other entity that is duly licensed or otherwise legally authorized to perform the same professional services as set forth in Article III or the general practice of law as allowed for in accordance with the Florida Statutes.

ARTICLE V

Capital Stock & Limitations on Ownership

- (a) The total number of shares of capital stock authorized to be issued by the corporation shall be 10,000 shares having a par value of \$1.00 per share. Shareholders must be duly licensed or otherwise legally authorized to practice law in order to be eligible to become a shareholder. Each of the said shares of stock shall entitle the holder thereof to one (1) vote at any meeting of the stockholders. The Board of Directors may authorize shares to be issued for consideration consisting of any tangible or intangible property or benefit to the corporation, including cash, promissory notes, services performed, promises to perform services evidenced by a written contract, or other securities of the corporation. Before the corporation issues shares, the Board of Directors shall determine that the consideration received or to be received for shares to be issued is adequate. All stock when issued shall be paid for and shall be nonassessable.
- (b) In the election of directors of this corporation there shall be no cumulative voting of the stock entitled to vote at such election.
- (c) No shareholder may sell or transfer his shares except to another professional corporation, professional limited liability company, or individual which is eligible to be a shareholder of the corporation.

ARTICLE VI

Registered Office and Registered Agent
