ARTICLE I.

CORPORATE NAME

The name of this corporation is F & K of Southwest Florida, Inc..

ARTICLE II.

ADDRESS OF CORPORATION

The address of the principal office of the Corporation, or the mailing address of the Corporation, if the principal office is not yet known, is 814 Neopolitan Way, Naples, Florida 34103.

ARTICLE III.

DURATION

The corporation shall have perpetual existence, commencing on the date of the execution and acknowledgment of these Articles or upon filing.

ARTICLE IV.

PURPOSE

NUMBER AND CLASS OF STOCK


