**ARTICLES OF INCORPORATION  
OF  
BOYNTON BEACH BACK, NECK AND PAIN CENTER, INC.**

The undersigned, acting as Incorporator of a Florida corporation ("Corporation") under the Florida Business Corporation Act, pursuant to Chapter 607 of the Florida Statutes, and other laws of the State of Florida, hereby causes to be delivered the following Articles of Incorporation for such Corporation:

**ARTICLE I  
NAME**

The name of the Corporation is BOYNTON BEACH THERAPEUTIC CENTER, INC., and the street address of the initial principal office of the Corporation is 3491 Woolbright Road, Boynton Beach, Florida 33426, and the mailing address of the Corporation is 3491 Woolbright Road, Boynton Beach, Florida 33426.
