This letter is in response to a telephone conversation earlier today with a staff member of this department at 850-245-6059. Enclosed you will find the following:

- 1) A completed Uniform Business Report for 2003 for my corporation, Appraisal Specialists, Inc., along with a payment of \$150.00.
- 2) A print-out of the information from the website for the Division of Corporations, as of today, April 28, 2003, for my corporation, Appraisal Specialists, Inc.
- 3) A print-out of the 2000 Uniform Business Report for Appraisal Specialists, Inc. from the Division of Corporations website as of today, April 28, 2003.
- 4) Individual checks in the amount of \$150.00 each for the payments for the Uniform Business Reports for Appraisal Specialists, Inc. for years 2001 and 2002.

Based on a review of the enclosed information and my conversation with the Division of Corporations staff member, it appears that a change of address indicated on the 2000 return was not picked up by the Division of Corporations. Please refer to the enclosed copy of this return. On the return copy that was filed, the address for Appraisal Specialists, Inc. was changed from 696 1st Ave. N., Suite 101, St. Petersburg, FL 33701 to 126 82nd Ave. N., St. Petersburg, FL 33702.

Please refer to the print-out of the current information from the Division of Corporations website for Appraisal Specialists, as of today's date. The old 696 1st Ave. N. address is still listed and the corporation is listed as inactive.

Apparently, the change of address indicated on the year 2000 return did not get picked up. According to the staff member who helped me, the packages for the year 2001 and year 2002 returns were erroneously sent by the Division of Corporations to the old address and were subsequently returned as undeliverable.

My accountant prompted me to file the year 2003 return before May first of this year. In doing so, I discovered that the returns for 2001 and 2002 had been missed. The staff member of the Division of Corporations who helped me suggested that 1)I fill out a return for 2003 and send in a check for \$150.00, 2)send in a letter describing the situation regarding the 2001 and 2002 returns that were missed, 3)request a waiver of the reinstatement fee and late filing fees for 2001 and 2002, and 4) send in two individual checks for \$150.00 for the 2001 and 2002 fees.

Hopefully this letter, together with the enclosed documentation and fee payments will resolve these issues. Please let me know If you have any questions or find that any additional information is needed.
