## CERTIFICATE OF INCORPORATION OF

## "PARALEGAL SERVICENTER, INCORPORATED"

FIRST: The name of the Corporation is "PARALEGAL SERVICENTER, INCORPORATED."

SECOND: Its principal office in the State of Florida is to be located at 3155 North West 42nd Street, in the City of Lauderdale Lakes, County of Broward.

The registered agent in charge thereof is: BRINSLEY M.A. ELLIOTT, Sr. at 3144 North West 42nd Street, Lauderdale Lakes, Florida 33309.

**THIRD:** The nature of the business and objects and purposes proposed to be transacted, promoted and carried on, are to do any and all things herein mentioned, as fully and to the same extent as any natural persons could or might do, in any part of the world, viz.:

"The purpose of the corporation is to engage in any lawful activity for which the corporations may be organized under the general Corporation Law of Florida."
