ARTICLE I.
NAME

The name of the corporation is: WARDAK SUBS, INC.

ARTICLE II.
PRINCIPAL OFFICE

The principal office of the Corporation (or the mailing address) will be: 1805 West Hillsboro Blvd., Deerfield Beach, FL 33442.

ARTICLE III.
DURATION

The corporation shall exist in perpetuity.

ARTICLE IV.
PURPOSE
