ARTICLE I - NAME

The name of the corporation shall be Machine Gun Charters, Inc. (hereinafter, the "Corporation" or the "Company").

ARTICLE VI - BOARD OF DIRECTORS


Section 1. Initial Board. The initial board of directors of the Corporation shall consist of two directors whose names and addresses are as follows:
