

The undersigned incorporator for the purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

FIRST: The name of the corporation is: **LOUIS FRIEND CONSTRUCTION COMPANY** (the "Corporation").

SECOND: The principal office address and mailing address of the Corporation is **855 Hollywood Boulevard, Hollywood, FL 33019**.

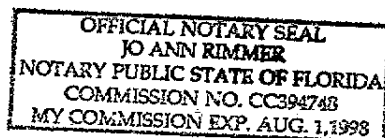
