

ARTICLES OF INCORPORATION
OF
FIBERGLASS MATERIALS & COATINGS, INC.

ARTICLE I. NAME

The name of this corporation is FIBERGLASS MATERIALS & COATINGS, INC.

ARTICLE II. DURATION

This corporation shall commence on January 1, 1998 and shall have perpetual existence.

ARTICLE III. PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV. CAPITOL STOCK

This corporation is authorized to issue 100 shares of \$1.00 par value common stock, which shall be designated "common shares".

ARTICLE V. PREEMPTIVE RIGHTS


