ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF

WELCOME HOMES PROPERTY INVESTMENTS, INC

Pursuant to Section 607.1001, Florida Statutes, the Articles of Incorporation of the above-named Corporation are amended as follows:

1. Article I of the Articles of Incorporation is hereby deleted in its entirety and replaced with the following:

"Article I. Name. The name of the Corporation is: WELCOME HOMES REALTY & INVESTMENTS, INC."

2. Pursuant to Section 607.1003, Florida Statutes, the foregoing amendments were proposed to the Shareholders by the Board of Directors and the number of votes cast for the amendment by the shareholders was sufficient for approval, and the amendment was adopted on March 20, 2001.

In all other respects, the Articles of Incorporation shall remain as they were prior to this Amendment being adopted.
