ARTICLE ONE

The name of this corporation is KRANTZ INDUSTRIES OF S.W. FLORIDA, INC. and the mailing address of the corporation shall be 3300 Davis Boulevard, Naples, FL 34104.

ARTICLE TWO

The date of the commencement of corporate existence of the corporation shall be the date these Articles are executed.


