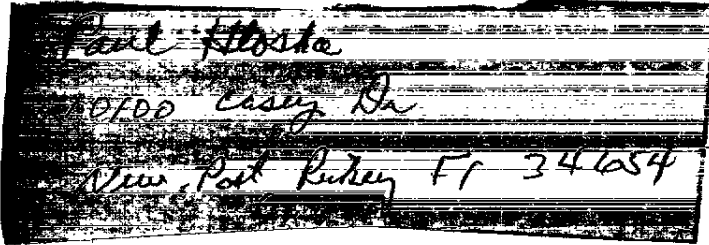

## **ARTICLES OF INCORPORATION**

### **HOME PRO ROOFING, INC.**

#### **ARTICLE 1 - NAME AND PRINCIPAL PLACE OF BUSINESS**

The name of the Corporation is HOME PRO ROOFING, INC. and its principle place of business shall be located at 10100 Casey Drive New Port Richey, FL 34654.

#### **ARTICLE II - DURATION**

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

#### **ARTICLE III - PURPOSE**

This corporation is organized for the purpose of transaction any and all lawful business.

#### **ARTICLE IV - CAPITAL STOCK**

This corporation is authorized to issue one class of stock, that stock being 1,000 shares of no par value, common stock, with identical rights and privileges, the transfer of which is restricted according to the bylaws of the corporation.

#### **ARTICLE V - PRE-EMPTIVE RIGHTS**

## ARTICLE VII - DIRECTORS

Initially, this corporation shall have one (1) Director who shall serve until their successor shall be elected/appointed at the first meeting of the shareholders and thereafter this corporation shall have no less than one (1) director constituting the initial Board of Directors.
