# SECOND ARTICLES OF AMENDMENT TO THE AMENDED ARTICLES OF INCORPORATION OF PREMIUM ASSET RECOVERY CORPORATION

Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida profit a corporation adopts the following Articles of Amendment to its Amended Articles of Incorporation:

FIRST: Article IV of the Articles of Amendment to the Articles of Incorporation, dated April 22, 2002, is being amended in its entirety as follows:

#### Article IV - Capital Stock

This corporation is authorized to issue One hundred sixteen thousand (116,000) shares of Class A Voting Common Stock, at one cent (\$0.01) par value per share, and Eighty-five thousand (85,000) shares of Class B Non-Voting Common Stock, at one cent (\$0.01) par value per share.

**SECOND:** The amendment was approved by the board of directors by unanimous written consent dated <u>April 27, 2006</u>.

**THIRD:** The amendment was adopted by at least a majority of the holders of the shares entitled to vote by written consent dated April 27, 2006, sufficient for the approval thereof.
