ARTICLE I - NAME AND BUSINESS ADDRESS

The name of this Corporation is Akulink Corp. Its business mailing address is 250 Catalonia Avenue, Suite 805, Coral Gables, Florida 33134.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

The purpose of this Corporation is to engage in any activities or business permitted under the Laws of the United States and Florida.

ARTICLE IV - CAPITAL STOCK

with the provisions of Section 48.091, Florida Statutes, as amended from time to time, with respect to keeping an office open for service of process.


ARTICLE VI - INITIAL BOARD OF DIRECTORS


