The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation.

ARTICLE I NAME

The name of the Corporation is Plentiful Corporation.

ARTICLE II DURATION

The duration of the Corporation is perpetual.
