ARTICLE 1. NAME

The name of the Corporation is TIMESHARE RESALES VACATIONS UNLIMITED, INC.

ARTICLE IL DURATION

This Corporation shall have perpetual existence.

ARTICLE III. PURPOSE.

This Corporation is organized to specifically sell memberships in a vacation exchange club

ARTICLE IV. CAPITAL STOCK

This Corporation is authorized to issue 1,000 shares of one (\$1.00) par value common stock.

ARTICLE V. MANAGEMENT
