ARTICLES OF INCORPORATION
OF
ABCutler PUBLISHING CO.

The undersigned, acting as incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for the corporation:

ARTICLE I
Name

The name of the corporation is ABCutler PUBLISHING CO.

ARTICLE II
Initial Principal Office and Mailing Address

The address of the principal office and the mailing address of the corporation is 1111 North Westshore Boulevard, Suite 412, Tampa, FL 33607.

ARTICLE III
Shares

The number of shares the corporation is authorized to issue shall be 10,000 shares of common stock. The shares shall have no par value. The common stock of the corporation shall be divided into two (2) classes, 5,000 shares thereof being known as Class A common stock, and 5,000 shares thereof being known as Class B common stock. The Class B common stock shall be distinguished from Class A common stock, in that the Class B common stock shall have no voting privilege or power. In all other instances Class B common stock shall have full rights, privileges and powers with Class A common stock.

ARTICLE VI
Initial Director

ARTICLE VII
Purposes

The purposes of the corporation shall be to conduct any and all lawful business and activities, including but not limited to public and private (in all media and in all places, whether inside or outside of Florida) publishing, communicating, disseminating, distributing, duplicating, reproducing, planning, managing, designing, processing, consulting, testing, evaluating, referring, scheduling, instructing, training, researching, compiling, inspecting, entertaining,

interpreting, translating, demonstrating, controlling, fabricating, servicing, and organizing, whether for profit or not for profit, or otherwise.
