There appears to be some ambiguity surrounding the filing of our annual reports for the business year in question. We received correspondence from your offices back in late July requesting a filing for Creed Touring, Inc. and Creed Merchandising, Inc. The correspondence also indicated that it was your offices second request for the reports. However, it was the first time our offices received such a request. The reports for each company were due no later than 9/15/98, which we complied with at that time. A few weeks later we received correspondence again from your office indicating that we needed to have an agent sign line 11 of the form and return it you within thirty days, which to my knowledge was complied with again. However, when we received correspondence from your office indicating potential dissolution of Creed Merchandising, Inc. and Creed Touring, Inc. due to lack of compliance, we decided to call and look into it by phone. We had only inquired about the status Creed Touring, Inc. (which I learned was in active status) because the two companies (Creed Touring, and Creed Merchandising) were filed with your office at the same time and date. The employee at your office assured me that the letter had crossed in the mail with my updated reports and that Creed Merchandising would also be in active status as soon as the records were updated. A few weeks later, I received correspondence again from your office indicating dissolution of Creed Merchandising, Inc. with a returned check. Since Creed Touring, Inc and Creed Merchandising, Inc. were filed at the same time and date, it is puzzling to us that one is active and the other requires more fees to be granted active status. We respectfully request that you please accept our original check of \$550 as well as our application as originally filed, and restore us to active status as soon as possible.

It should be noted that Creed Touring, Inc.'s filing fees cleared our bank, so we are assuming that entity continues to be in good standing.
