
To whom it may concern:

Our Corporation, American Home Inspection, inc., just received a 2nd notice for the 1999 Profit Corporation Annual report, Filing Fee plus penalty for a total of \$ 550.00. This is the first notice we have received. I do not know if the first notice was not sent to us or if it was lost in the mail.
