### ARTICLES OF INCORPORATION OF 1059, INC.

#### ARTICLE I - Name

The name of the corporation is: 1059, INC.

#### ARTICLE II - Purposes

- 1. This corporation is organized for the purpose of transacting any and/or all lawful business including, but not limited to, ownership and management of a restaurant and related activities.
- To act on its own behalf in all legal or equitable proceedings or suits.
- 3. To acquire, hold, use, deal in, encumber, dispose of property, real or personal, and any interest therein.

- 8. To carry on any or all of its operation and businesses and to promote its objectives within the State of Florida or elsewhere, without restriction as to place or amount; and to have, use, exercise and enjoy all of the general powers of like corporations.

To do any or all of the things herein set forth to the same extent as natural persons might do, in any part of the world as principals, agents, contractors or otherwise, alone or in company with others, and to do and perform all such other and further things and acts as may be necessary, profitable or expedient in carrying on any of the business or acts above named.
