

ARTICLE I. NAME

The name of this corporation is WIDMANN ENTERPRISES, INC.

ARTICLE II. DURATION

This corporation shall begin its existence on the 19th day of November, 1997.

ARTICLE III. PURPOSE

This corporation is organized for the purpose of engaging in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is:
