ARTICLES OF INCORPORATION

WE, the undersigned, hereby associate ourselves for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida, providing for the formation, liability, rights, privileges, and immunities of a corporation for profit.

ARTICLE I.

The name of the corporation shall be: " Les Bons Temps Roullez, Inc.

ARTICLE II.

The general nature of the business to be transacted is to engage in any activity of business permitted under the laws of the United States and the State of Florida.

ARTICLE III.

The authorized capital stock of the corporation shall be 1000 shares of common stock, \$1.00 par value. All of said stock shall be payable in cash, property, labor or services at a just valuation to be fixed by the Board of Directors. Property, labor or services may be purchased or paid for with the capital stock at a just valuation to be fixed by the Board of Directors at a meeting called for that purpose.

ARTICLE IV.

The amount of capital with which this corporation shall begin business shall be \$100.00.

ARTICLE V.

This corporation shall begin existence on the date of the incorporation by the Secretary of State's office, and shall have perpetual existence, unless sooner dissolved according to law.

ARTICLE VI.

The street address of the initial registered office of this corporation is 12901 McGregor Blvd, Unit 16,17, Ft. Myers, FL 33919-4587, and the name of the initial registered agent of this corporation at that address is Shirley K. Jackson.

ARTICLE VII.

The business of the corporation shall be managed by a Board of Directors, consisting of two initial Directors, but the number may be changed in the By-Laws.
