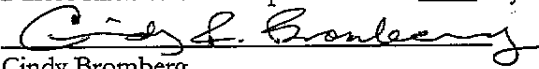

Articles of Incorporation**

EFFECTIVE DATE
11/14/97

The undersigned, subscriber to these articles of incorporation, a natural person competent to contract hereby presents these articles for the formation of a corporation under Florida law.

1. The name of the corporation shall be CB Interiors Group, Inc.
2. The corporation shall be organized to have a maximum of 100 shares of common stock outstanding at any one time. The shares of the outstanding stock shall have a par value of \$1.00 per share.
3. The corporation may engage in any activity or business permitted in Florida.
4. The initial address of the principal office and registered office and the name of the registered agent shall be Cindy Bromberg, 3441 NE 170th Street, North Miami Beach, FL 33160. The board of directors shall from time to time move the office of the registered agent to any address in Florida.
5. Initially the corporation shall have ONE director and their number shall be increased or diminished from time to time by the by-laws adopted by the shareholders.
6. The amount of capital which the corporation begin business is \$500.00.
7. The corporation shall exist perpetually.
8. The name and address of the first board of directors is Cindy Bromberg located at 3441 NE 170th Street, North Miami Beach, FL 33160.
9. The name and post office address of the subscriber to these articles of incorporation and the number of shares she has agreed to take is Cindy Bromberg located at 3441 NE 170th Street, North Miami Beach, FL 33160, 100 shares.
10. These articles of incorporation may be amended in any manner provided by law. Every amendment shall be approved by the board of directors, proposed to them by the shareholders, and approved at a shareholders' meeting by a majority of shares entitled to vote thereon, unless the shareholders and directors sign a written statement manifesting their intention that a certain amendment to these articles be made.
11. The effective date of the corporation shall be November 10th, 1997 or as soon thereafter as possible.

The undersigned incorporator(s) have executed these Articles of Incorporation this 19th day of November, 1997.

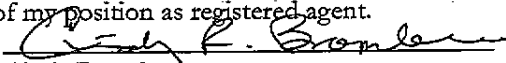
