

FOR

The undersigned, acting as incorporator of a corporation under the Florida Business Corporations Act, adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation is "CAMNER FAMILY CORPORATION"

ARTICLE II

The principal office and mailing address of this corporation is c/o Alfred R. Camner, 550 Biltmore Way, Suite 700, Coral Gables, Florida 33134.

ARTICLE III

The duration of this corporation is to be perpetual.

ARTICLE IV

The corporation may engage in any activity or business permitted under the laws of the State of Florida.

ARTICLE V

The corporation shall have authority to issue 100 shares, all of one class, \$.01 par value.

ARTICLE VI

The street address of the initial registered office is c/o Alfred R. Camner, 550 Biltmore Way, Suite 700, Coral Gables, Florida 33134. The name of the corporation's registered agent at such address is Neale J. Poller.

ARTICLE VII

The number of directors constituting the Board of Directors shall be fixed as provided by the bylaws, but shall not be less than two.

ARTICLE VIII

The name and address of the incorporator is Nikki J. Nedbor, 550 Biltmore Way, Suite 700, Coral Gables, Florida 33134.


ARTICLE IX
