# ARTICLES OF INCORPORATION of Volusia Family Practice, P.A.

97 MOV 24 ED
TALLAHASSEE TO TALLE 37

The undersigned person, acting hereby as Incorporator for the purpose of forming a Approfessional Service Corporation for profit under the provisions of Chapter 607, Florida Business Corporation Act, and Chapter 621, Florida Professional Service Corporation Act, of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

#### ARTICLE I

Name of Corporation, Principal Office, and Mailing Address

The name of the Corporation is: Volusia Family Practice, P.A.

The principal office of the Corporation will be 1385 West Granada Boulevard, Ormond Beach, Florida 32174.

The Mailing Address of the Corporation will be 27 Southern Pine Trail, Ormond Beach, Florida 32174.

#### ARTICLE II

#### **Purposes**

The general nature and purposes of business to be transacted, promoted and carried on by the Corporation are as follows:

- a) To engage in every aspect of the practice of medicine, and all its fields of specialty.
- b) To engage and render the professional services involved only through its officers, agents, and employees who shall be physicians in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the same professional service as this Corporation.
- c) To invest its funds in real estate, mortgages, stocks, bonds and any other type of investments permitted by law.
