OF

The undersigned, acting as incorporator of Digital Marketing Technologies, Inc., under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

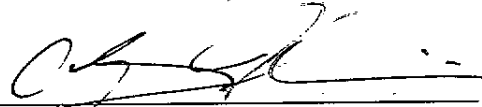
