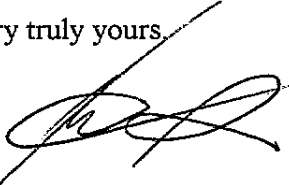

I/WE, the undersigned natural person competent to contract acting as incorporator of corporation under the General Corporation Law of the State of Florida, make subscribe, acknowledge and file the following Articles of Incorporation for such corporation.

**ARTICLE I**

**NAME**

The name of the corporation is:

**ARTICLE II**

**GENERAL NATURE OF BUSINESS**

The general nature of the business to be transacted is:

To engage in any activity or business permitted under the laws of the United States and of the State of Florida.

**CAPITAL STOCK**

The amount of authorized capital stock is One Hundred Dollars (\$100.00), consisting of one hundred (100) shares of common stock, having a par value of One Dollar (\$1.00), per share.

**ARTICLE IV**

**PREEMPTIVE RIGHTS**

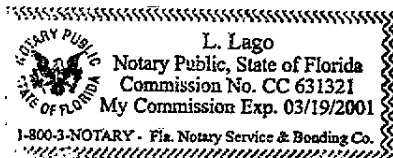
