## ARTICLES OF INCORPORATION OF

### PACIFIC INTERNATIONAL OF FLORIDA CORPETARY OF STATE

TALLAHASSEE, FLORIDA

Know to all men by these presents: That the undersigned incorporator hereby certifies that he has formed a body corporate under and by virtue of the laws of the state of Florida for the transaction of business with and under the following charter:

Article I: Name -- The name of the corporation shall be PACIFIC INTERNATIONAL OF FLORIDA CORP., with its principal office located at 5945 Crystal View Drive, Orlando, Florida 32819-4210.

Article II: Duration -- The corporation shall have perpetual existence, unless terminated in the manner prescribed by the laws of the state of Florida.

Article III: Purpose -- The purpose for which the corporation is formed is to engage in any lawful activity or business.

Article IV: Capital Stock -- This corporation is authorized to issue 1000 shares of one dollar (\$1.00) par value voting common stock. Said stock shall be issued only as and when and for such consideration as determined by the incorporator or stockholders.

Article V: Initial Registered Office and Agent -- The street address of the initial registered office of the corporation is 5945 Crystal View Drive, Orlando, Florida 32819-4210, and the name of the initial registered agent of this corporation at that address is NANA LI.

Article VI: Incorporator -- The name and address of the person signing these articles is:

Article VII: Management by Stockholders -- The business of the corporation shall be managed, controlled and conducted by the stockholder(s) of the corporation, as shall be provided for in the bylaws from time to time, and such other officers, if any, as shall be provided for in the bylaws from time to time; provided, however, that as long as the business of the corporation is managed, controlled and conducted by the stockholders of the corporation, then:

- A. Wherever the context requires, the Stockholder(s) of the Corporation shall be deemed director(s) of the Corporation for purpose of applying the provisions of Florida Statues;
- B. The Stockholder(s) of the Corporation shall be subject to the liabilities imposed by Florida Statues for action taken by Director(s);
- C. Any action required or permitted by the Florida Statues to be taken by the directors of the Corporation may be taken by action of the Stockholder(s) of the Corporation at a meeting of the Stockholders or as hereinafter provided.

The Stockholder(s) shall have the power to fix the amount of all salaries and other compensation paid by the Corporation, including their own salaries as director(s), officer(s) or otherwise.

The Stockholder(s) shall have the power to adopt, amend and repeal bylaws not consistent with law or Articles of Incorporation of the company; Provided, however, that the Stockholder(s) shall be subject to the power of the holders of the outstanding stock of the company to change or repeal such bylaws or any of them.

The first annual meeting of the Stockholder(s) shall be held at such time and place as may be designated in the bylaws of the Corporation.

If the business of the Corporation is managed, controlled and conducted by the Stockholder(s), then any action of the Stockholder(s) of the Corporation may be taken without a meeting if consent in writing, setting forth the action so taken, shall be signed by a majority of the persons who will be entitled to vote upon such action at a meeting and filed as a part of the Corporate records. Such consent shall have the same force and effect as a vote of the Stockholder(s).

Article VIII: Corporate Powers — This Corporation shall have all powers granted to corporations by Florida Statues unless otherwise provided bylaws of the corporation.

Article IX: Stockholder(s) Not Personally Liable for Corporate Debts -- The private property of the Stockholder(s) should not be liable for the payment of debts of the corporation to any extent whatsoever except for the balance unpaid on any of their stock subscriptions.

Article X: Amendment: -- This Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment hereto, any right conferred upon the shareholders is subject to this reservation.

Article XI: Commencement of the Corporate Existence -- In accordance with Section 607.167,

.Florida Statues, the date when corporate existence shall commence is the date of subscription and acknowledgement of these Article of Incorporation.
