**ARTICLES OF INCORPORATION**

of

**MERCHANDISE UNLIMITED OF AMERICA, INC.**

The undersigned, a natural person competent to contract, acting as incorporator of a corporation under the Florida General Corporation Act, Chapter 607, Fla. Stat. (1997), as amended, adopts the following Articles of Incorporation for such Corporation.

**Article 1**

Name

The name of this corporation is:

**Merchandise Unlimited of America, Inc.**

**Article 2**

Duration

The duration of this corporation shall be perpetual, commencing on the date these Articles are filed in the office of the Secretary of State of Florida.

**Article 3**

Purpose

The purpose of this corporation is to engage in any activities or business permitted under the laws of the United States and Florida.

**Article 4**

Capital Stock

The corporation is authorized to issue 1,000 shares of common stock with each share having a par value of \$.001. All shareholders shall have preemptive rights in future stock sales by the corporation.

**Article 5**

Initial Principal Office and Registered Agent

**Article 6**  
Board of Directors

The corporation shall have one director. The number of Directors may be increased or decreased from time to time by an amendment of the Bylaws of the corporation, but shall never be less than one.

**Article 7**  
Incorporator

**Article 8**  
Amendment of Articles

The Articles of Incorporation may be amended in the manner provided by law, unless otherwise provided by the Bylaws of the corporation. The corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, and any right conferred upon the shareholders is subject to this reservation.

**Article 9**  
Indemnification

The corporation is empowered to indemnify any officer or director, or any former officer or director, pursuant to the Bylaws and to the provisions of Section 607.014, Fla. Stat. (1997), as amended.

**Article 10**  
Informal Action of Directors

If all the directors severally or collectively consent in writing to any action taken or to be taken by the corporation, and the writings evidencing their consent are filed with the Secretary of the corporation, the action shall be as valid as though it had been authorized at a meeting of the Board of Directors.

**Article 11**  
Inspection of Accounts and Books

The rights of the shareholders to inspect the books and accounts of this corporation shall be as conferred by the Bylaws, resolutions of the shareholders, or as required by law.

**Article 12**  
Powers of Directors

The directors shall have power to make and to alter or amend the Bylaws; to fix the amount to be reserved as working capital; and to authorize and cause to be executed mortgages and liens, without limit as to the amount, upon the property and franchise of the

corporation. With the written consent of the holders of a majority of the capital stock issued and outstanding, the directors shall have the authority to dispose of, in any manner, the whole property of this corporation.

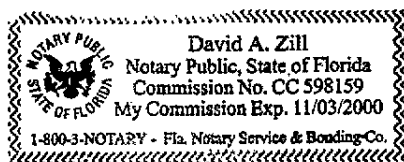
