ARTICLES OF INCORPORATION

OF

TURNBULL BAY, INC.

The undersigned incorporators hereby make, subscribe to, acknowledge and file these Articles of Incorporation for the purpose of organizing and incorporating a corporation for profit under the laws of the State of Florida.

ARTICLE I

The name of the corporation shall be:

TURNBULL BAY, INC.

and it shall hereinafter be referred to as the "corporation".

ARTICLE II

The time and date of which corporate existence of this corporation shall begin is upon filing with the Secretary of State for the State of Florida, and this corporation shall have a continuous and perpetual existence thereafter.

ARTICLE III

The general purpose for which the corporation is initially organized is to transact any and all lawful business for which a corporation may be incorporated under Chapter 607, Florida Statutes, as amended.

ARTICLE IV

The aggregate number of shares which the corporation shall have authority to issue is: 100. These shares shall consist of one class only, and such class shall be known as "common stock" of the corporation. Each share shall have a par value of One

Dollar (\$1.00) per share. The initial capital of the corporation shall be \$100.00.

ARTICLE V

The street address and mailing address of the initial registered office of the corporation shall be: 1460 Ocean Shore Boulevard, Ormond Beach, Florida 32176. The name of the initial registered agent shall be: **ROBERT L. HILLMAN**. To signify the acceptance of appointment as registered agent, the registered agent named in this Article has signed these Articles as required by law.






