The undersigned incorporator delivers these Articles of Incorporation to form a corporation under the law of the Florida Business Corporation Act.

ARTICLE I

Name. The name of the corporation is:

Greendale Investments, Inc.

ARTICLE II

Principal Office. The principal office and mailing address of this corporation is 6755 Poley Creek Drive, West, Lakeland, Florida 33811.

ARTICLE III

Business and Activities. This corporation may, and is authorized to, engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE IV

Capital Stock. The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 1,000 shares of common stock having \$1.00 per value, with the consideration to be paid for each share to be in money, property or services, as may be fixed by the Board of Directors.

ARTICLE V

Term of Existence. This corporation shall have perpetual existence.
