In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I. NAME

The name of the corporation ("Corporation") is ST. FRANCIS CENTER FOR ENVIRONMENTAL POLICY, INC.

ARTICLE II. ADDRESS

The address of the principal office of the Corporation is P.O. Box 3241, St. Petersburg, FL 33731.

ARTICLE III. COMMENCEMENT AND DURATION

The existence of the Corporation will commence on the date of filing of these articles of Incorporation by the Department of State of the State of Florida. The term of existence of the Corporation is perpetual.

ARTICLE IV. AUTHORIZED SHARES

The maximum number of shares this Corporation is authorized to issue is 1000, all of which shall be Common Shares. The Board of Directors of the Corporation may authorize shares to be issued for any consideration as provided by law.

ARTICLE V. REGISTERED OFFICE AND REGISTERED AGENT
