

**ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION OF
MARTIN SEPTIC SERVICE, INC.**

Pursuant to the provisions of Section 607.1006, Florida Statutes, Martin Septic Service, Inc., a Florida corporation, (the "Corporation"), hereby amends its Articles as follows:

ARTICLE I OF AMENDMENT

Article I, of the Articles of Incorporation shall be deleted in its entirety and replaced with the following:

ARTICLE I. NAME

The name of the corporation is T- Scott Enterprises, Inc.

ARTICLE II OF AMENDMENT
