**ARTICLES OF INCORPORATION
OF
SPEECH THERAPY CLINIC, INC.**

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation:

**ARTICLE I
NAME**

The name of the corporation is SPEECH THERAPY CLINIC, INC.

**ARTICLE II
STREET ADDRESS OF INITIAL PRINCIPAL
OFFICE/MAILING ADDRESS OF CORPORATION**

The street address of the initial principal office of the corporation and the mailing address of the corporation is 7840 N.W. 178th Street, Miami, FL 33015.

**ARTICLE III
AUTHORIZED SHARES**

The aggregate number of shares which the corporation is authorized to issue is 100. Such shares shall be a single class and shall have a par value of \$0.01 per share.
