ARTICLES OF INCORPORATION

ARTICLE I. NAME

The name of this corporation shall be Mercedes Salguero, P.A.

ARTICLE II. DURATION

This corporation shall have perpetual existence commencing on the date of filing of the Articles of Incorporation by the Department of State.


